# **1 General Data**

### **Application Fields**

PORPLASTIC S6000P is used as colour-stable elastic top finish for elastic PORPLASTIC INDOOR & OUT-DOOR coating systems.

#### **Product Description**

PORPLASTIC S6000P is a solvent-free, low emission, water-based, coloured two component PU-based top finish with matt surface finish made from high-quality aliphatic polyurethane resin.

The product is light-stable, shows high stress resistance combined with long-lasting elasticity. PORPLASTIC S6000P has good chemical resistance against diluted acids and alkalis and many disinfectants. Depending on the substance in contact with the flooring (please not that wine or coffee etc. are also relevant) discolorations may occur, which will not reduce the usability of the flooring (please refer to the chemical resistance list).

PORPLASTIC S6000P also improves the scratch and abrasion resistance of coatings.


For bright colours and some colourful shades we recommend the application of the seal coat in two layers to increase the opacity. Also the colour of the previous layer should be similar to the colour of the top finish.

The product fulfils German AgBB requirements for VOC emission.

# **2 Processing Instructions**

### **Substrate Preparation**

PORPLASTIC S6000P

#### PUR-systems:

The substrate has to be clean, dry and free of contaminants such as oil, grease, paint. PORPLASTIC S6000P is applied to elastic PORPLASTIC INDOOR & OUTDOOR PU-coatings. The top finish should be applied within the recoating interval of the previous layer.

#### Retopping

Please contact our technical support before re-topping old PU surfaces.

Adhesion tests should be carried out and they will determine the substrate preparation. In all cases the surface must be thoroughly cleaned and left to dry completely. The sealing should be applied at least 2 d after the coating. Afterwards it may be necessary to grind and remove the dust before applying PORPLASTIC S6000P.

### Processing

The product is delivered in 2 component containers in the exact mixing ratio. The A-component is stirred for at least 1 - 2 minutes. Then the entire contents of the B-component are emptied into the A-component container and both are stirred for about 3-4 minutes using a suitable electrical stirrer. The material should be passed through a sieve when pouring into another container before processing (either with a paint filter sieve of 0.6 - 1 mm mesh size, or with a household sieve with inserted fly screen or similar fabric, mesh size <1mm) and mix again briefly. The inclusion of air in the stirring process must be avoided.

PORPLASTIC S6000P is poured onto the surface in portions and is spread with short pile roller or rubber squeegee in one direction over the surface. Then it is spread with a wide short-piled micro-fibre roller (e.g. Multitool, pile-height about 6 - 8 mm) and homogeneously finished with a second roller in one direction. The formation of puddles should be avoided.

As with all water based top finishs, it is important to avoid dry edges by always working wet in wet when rolling fresh material into applied wet top finish otherwise roller marks will be visible in the final finish. Time between the overlapping should not exceed 2-5 minutes. Open time for rolling fresh material into the applied wet top finish without leaving any marks is at room temperature 3-5 minutes. During application drafts and direct sunlight should be avoided.

#### Cleaning:

Tools and other contaminated spots can be cleaned using water or VIASOL SO-X12 cleaner.

### Reworking

If reworking within 24 hours after application the coating need not be grinded. Reworking later than that is only possible after grinding and vacuuming it carefully.
